#### Cautions:

- The projections are not calculated in the report. They are encumbrance amounts (based on DOPE data) that are fed to the Data Warehouse and FIS Banner on a monthly basis. Encumbrances are calculated through the distribution end date. For indefinite end dates, encumbrances are only calculated through the end of the fiscal year. Encumbrances are not calculated for Stipends. Although some units on campus have elected to not use the encumbrances in FIS Banner, the amounts do still exist in the Data Warehouse and on this report.
- This report is based on the "monthly salary expense" information from PPS (a.k.a. the "DOPE"). Salary expense
  data is updated once per month typically by the 5th working day of the following month not necessarily at the
  same time the expenses are loaded to the campus financial system (FIS Banner).


